Executive summary

This report provides a quarterly progress update of the period 1 October to 31 December 2018 showcasing the innovative approaches that have benefited, or are expected to have a positive impact on, the lives of the people in the polders under the Blue Gold Program. This progress reporting is part of the management of the Blue Gold Innovation Fund (BGIF). For more details on the scope and set-up the BGIF, please consult the BGIF Procedure Manual V8- May 2018.

Projects under implementation

Seven projects are under implementation currently. Below the most interesting project updates are highlighted (for more information see chapter 1):

- United Purpose (UP) Phase II: Sustainable Water Management through Indigenous Finance & Technology (SWIFT). Q4 2018 progress was satisfactory. Main strengths of SWIFT: i) Good documentation, ii) Involvement of relevant government agencies at the relevant authority levels (DAE advise on recommended crops, BWDB endorsement of infrastructure), iii) Valuation and monetisation of in-kind contributions of community members, enhanced ownership, iv) Awareness improvement of available funding channels and procedures amongst community members and confidence to attract funding for small scale infrastructure. SWIFT phase III proposal will be received on 7 Feb 2019, which is likely to be accepted as performance so far has been remarkable. Proposal is likely to be 50,000 EUR
- MetaMeta Accelerating Horizontal Learning in BGP Polders: ICT as force multiplier. Project is fully operational in 10 polders and on track with implementation. Progress: 5/10 video trainings, 16/50 video screenings, 6/18 instruction videos produced, Facebook and Agtube websites have been developed. In addition, 1 video training for Union Digital Centre (UDC) members has been added to project activities.

In Q3-2018, UP intensified its coordination with BGP Patuakhali team and has developed a realistic workplan. Two batches training for WMG executive committee members on Communication and Leadership held on 17-18 October and 22-23 October at polder 43/2A and 55/2A respectively. In the first training 17 (all male) and 15 participants (Female 6) participated in the second training. In the reporting period, a number of field visits took place: 23.10.2018 training program on 'Leadership and Communication training for Resource Mobilization and Advocacy' organized by at polder 55/2A. Fifteen participants (4 female) attended the program. 20.12.2018 Mativanga in polder 43/2B under Patuakhali Sadar upazila. Observed two constructed gated pipe culverts and had discussion with community people including land owning farmers, WMG members, UP member and SWIFT field staffs. The progress seems satisfactory. It was good to know about the way field staffs could mobilize farmers in contributing in construction work. Both the structures still need earth work and wooden gates. BGP engineer, who was with the visiting team, provided advice on little technical issues. Good cooperation and coordination among concerned SWIFT and zonal BGP staffs. 22.01.2019. Progress review meeting held at Patuakhali with SWIFT field staff. Observed good documentation and endorsement of infrastructure by BWBD, Blue Gold. DAE also advise on recommended crops. BGP Team Leader and BGIF managers visited SWIFT field activities and observed two FCDI projects (culvert and microdam). UP Chairman, WMG leaders and farmers were present during the field visit. Farmers are happy with the production of Pangus but availability of fingerling round the year is their concern. Innovision's Pangas phase III is uncertain, phase II performed well but it's impact was limited to direct beneficiaries, and its unclear whether the project actually solves a big problem (in the supply chain) for beneficiaries or simply increases their (moderate) profits. Progress review meeting with CIMMYT at Patuakhali 21.01.2019. 18 focus group discussions (90 farmers participated, 40% were women) have been held which yielded insight in historical experiences with rainfall during the mung bean harvesting season and how this affected profitability. CIMMYT now has a good understanding of the preferences farmers have for receiving the information through applications. As smart phones are not widely used, voice and text messages to around 70 farmers directly is a viable option. Additionally, they connected people like imams could also be informed daily and they could relay the message to their networks. CIMMYT will submit an updated activity chart. An MSc student will conduct a study soon on the social network/ power structures, the result of which will be used in the second round of testing the application in the field. The next harvest season will start in Feb. The CIMMYT team is confident the app will be ready by this time. The project thus seems performing well, despite having a late start. A presentation and discussion was held on December 11, 2017 at Program Coordinating Director's Office, PCD Mr. Amirul Hossain, Focal Point of DoF Dr. Sainar Alam, District Fisheries Officer, and BGP TA Team experts attended the session. Another workshop was conducted on 18 January at local level to discuss the possible follow-up within polder 2. We are also in discussion with Dr. Jahangir Alam to evaluate other aquaculture interventions within the BGP area. The delivery of the final report of the project has unfortunately been delayed with almost 6 months. Feedback by our team has been provided in Sep 2018. Final version was submitted on 04 November 2018.

There are no concepts under development, since our application deadline closed on 15 July 2018 and we have already made a selection of organisations which we would like to proceed with for further proposal development and potential project implementation.

However, we have asked United Purpose to re-submit a proposal for Women Business Centres phase III and similarly to Innovision for the Pangasius project phase III. These have been received in January 2019 and are currently pending BGIF management decision whether lessons learned in phase II have been incorporated in the next phase.

SWIFT proposal phase III (also by United Purpose) is due in February 2019.



The Water Management Fund has 3 running projects: Meta Meta - Accelerating Horizontal Learning in Bangladesh Polders: ICT as Force Multiplier (EUR 129k) and United Purpose- Phase II: Sustainable Water through Indigenous Finance & Technology on 1 May 2018 (EUR 50k), Khulna University: Water Hyacinth (EUR 50k), signed 29.01.2019, active 01.02.2019.

The Productive Sector Fund has 4 running projects: United Purpose – Women Business Centres (EUR ~60k); mPower - Breed Identification and Digital Registry of Cattle project in March (EUR 132k); Innovision Agro Services - Pilot on augmenting homestead pangasius aquaculture productivity in three Upazilas of Patuakhali (EUR 50k); CIMMYT project – Leveraging decision making science to sustain climate and market-smart mungbean advisories for Patuakhali's polder communities (EUR 132k). Practical Action – Sack farming and agromet services (EUR 50k) – signed 20.12.2018, active 01.02.2018.

Future planning

3 Pipeline PHASE III projects:

- 1) SWIFT phase III proposal has been received on 7 Feb 2019, which is likely to be accepted as performance so far has been remarkable.
- 2) WBC phase III is uncertain, performance phase II was sub-optimal appraisal ongoing whether lessons have been learned from phase II. Revised proposal received 20-01-2019.
- 3) Innovision's Pangas phase III is also uncertain, phase II performed well but its impact was limited to direct beneficiaries, and its unclear whether the project actually solves a big problem (in the supply chain) for beneficiaries or simply increases their (moderate) profits. Within February 2019 a decision will be taken whether this project should be continued or not.

Assuming we will stick to our semi-committed allocations and keep management handling fees in line with current spending (around 13%), we have about EUR 50k remaining to spend.

Khulna University is tasked to identify a partner to implement the business promotion component of the project. This partner will submit a ToR and budget to implement the extra activities (these extra activities will be linked to the joined workplan that will trigger payments).
