
Blue Gold Program Catchment Planning – Evolution of Process and Organisation

This note summarises the approach to polder catchment planning from its start in mid-2018 to a modified form in mid-2019 which incorporated the practical experience gained in a year of implementation.




Process

- (a) During a 5 day workshop, the Catchment Committee Facilitators (CCF) of 1 or 2 polders are trained.
- (b) The catchment committee facilitators independently organize WMG planning resulting in WMG plans.
- (c) The WMA-O&M Subcommittee sits to discuss the WMG plans and to identify common issues resulting in a draft Catchment plan (including actions + maps).
- (d) The draft catchment plan is presented at the Union Parishad level, also inviting BADC and other organizations that may contribute to agriculture through improved water management.

Organization

- (a) WMGs send max 4 representatives (PWMR 2014) to the WMA to act on their behalf. WMA General Committee is formed by all representatives of the WMGs.
- (b) WMA may form subcommittees (PWMR 2014). Within the Blue Gold program, O&M subcommittees are formed at the (sluice) catchment level and are sometimes referred to as catchment committees. The Blue Gold Program include one or two Catchment Committee Facilitator (CCF) in these O&M subcommittees. They are trained to facilitate the catchment planning process. These CCFS are selected from one or two WMGs within the catchment.
- (c) WMGs within the respective catchment select and send a few of their members to form the WMA-O&M subcommittee at the catchment level.

Process

- (a) During a 5 day workshop, of every catchment 1 or 2 members will be selected from the O&M subcommittee members to be trained.
- (b) These members independently organize WMG planning resulting in WMG plans.
- (c) The WMA-O&M Subcommittee sits to discuss the WMG plans and to identify common issues resulting in a draft Catchment plan (including actions + maps).
- (d) The draft catchment plan is presented at the Union Parishad level, also inviting BADC and other organizations that may contribute to agriculture through improved water management.

Organization

- (a) WMGs send max 4 representatives (PWR 2014) to the WMA to act on their behalf. WMA General Committee is formed by all representatives of the WMGs.
