## INTRODUCTION

January 23, 2019 Blue Gold – Patuakhali zone organized “Agreement Signing Ceremony on Operation & Maintenance between WMA and BWDB” at Islamic Foundation Auditorium, Patuakhali. The objective of this program was to make both the parties agreed on the roles & responsibilities of WMA & BWDB on the overall operation and maintenance of Water Management Infrastructures under specific polders, signing agreement & formally handing over the documents among the partners.

A Total of 18 Water Management Association from the 06 Polders 43/1, 43/2F, 43/2B, 43/2D, 55/2A, 55/2C Executive Committee members attended the program from Patuakhali and Barguna District. Following table shows the details of WMA participants.

## THE PROGRAM

The Program was started at 10.00 AM and continued till 01.00 PM. Following were the key session of the program:

1. Video show on news compilation on BGP activities which were published in different Television Channel, National News Paper;
2. O&M agreement signing, handing over and distribution among the WMAs, Photo session
3. Distribution of WMA registration certificates among 18 WMAs by the Chief Water Management Officials, BWDB;
4. After signing agreement of O & M (Operation & Maintenance) a social drama was staged to reflect the role of WMA (Water Management Association) in building confidence on how to carry out the operation and maintenance activities by the WMAs in boosting water management, agricultural production and economic development.



The Project Coordinating Director (PCD) Mr. Amirul Hossain presided over the program. Mr. Md. Hasanuzzaman, Executive Engineer (XEN) and Patuakhali O&M Division, BWDB, Patuakhali welcomed the participants and Mr. Md. Moshir Rahman, XEN, O&M Division, Barguna has clarified the importance of O&M Agreement in between BWDB & WMA and Roles of BWDB to implement the Agreement.



The Executive Engineers, BWDB from Patuakhali, Barguna and Chairperson of Water Management Associations signed O&M agreement & handed over the documents to WMAs. Mr. Md. Masud Karim, Chief Extension Officer, BWDB, Dhaka, distributed the WMA Registration Certificates among 18 Water Management Associations.

Md. Mazibur Rahman, Superintendent Engineer Patuakhali Water Development Circle, BWDB, Patuakhali, Md. Hridoyessor Datta, Deputy Director, DAE, Patuakhali and Mr. Matiur Rahman, Deputy Director, DAE, Barguna in their speech largely focused on BWDB and DAE's role in implementing the O&M activities.

Specially, Ms. Munimjan Akter, Joint Secretary, Goshkhali Sluice WMA, Polder 43/2F pointed out that to what extent the Blue Gold Program has contributed them as well as to make them confident in the preparation of O&M plans, generate O&M funds, encourage and involved in collective actions, developed linkages with the BWDB, DAE, BADC, LGED and other private sectors which make them highly self-dependent.
