Training on Monitoring & Quality Control for Earth Work

Participants: Monitoring & Quality Control committee members, Contractor and LCS Leaders

Date: 19-20 May, 2015



Short Training courses of six batch of three Polder (i.e. Polder-43/2A, 43/2B and 43/1A) on Monitoring and Quality Control for Earth Work for the members of Monitoring Committee were held in Patuakhali from 19 May to 20 May, 2015 to familiarize with the techniques of monitoring and quality control of Earth Work on going in the polder area under Blue Gold Program. These training courses were organized to inform about the earth work to the monitoring committee members and to introduce the monitoring committee members with the LCS members and Contractors.

In these training courses, the monitoring committee members, WMA representatives and representatives of LCS participated and Representative of Component-1 and 2, BWDB representative and Training Coordinator attended as a resource person. The Training was started very informally with introducing each other and then the roles and function of Monitoring Committee was discussed. After that the procedures of monitoring and quality control of earth work (specially filling up the checklist for monitoring and quality control provided by Blue Gold Program) also explained.

The participants of these training courses were actively participated in the training and they expressed their gratitude to Blue Gold Program for organizing such kind of training which is very effective for quality earth works. They also argued that these training courses should be organized at the beginning of rehabilitation works as the training was take place after a significant progress of earth work was achieved in some polder (especially in Polder-43/2B , where about 50% work was done). In the Training it was decided that a joint visit (with component-2 and BWDB representatives) will be organized by Monitoring Committee in each area of concerned polder for better monitoring and quality controls.
