A total of 30 Farmer Trainers (FT) attended the 4th batch of TOT course on Homestead-Local Poultry module with market orientation. Two weeks long ToT course course was organized to develop their knowledge and skills on Homestead vegetable and local poultry production with market orientation.

## 1.1 Objectives of the TOT

- To familiarize FTs with Blue Gold activities
- To familiarize FTs with FFS approach
- To increase capacity of FTs as a facilitator following participatory approach
- To provide technical information on Homestead-Poultry modules with market orientation
- Understanding on collective action, business plan, budgeting, record keeping, ICT etc

## 1.4 Course contents with day schedule

The following contents followed day by day for Homestead and Local poultry production with market orientation, facilitations skill , basic principle of FFS, Blue Gold activities etc.

**Day 1:**

Introduction , inaugural, group dynamics, expectation, training principle , farming is a business

**Day-2:**

Water Management Group (WMG) formation process and function, Value Chain and sustainable homestead production (Hg &Poultry), Community meeting

**Day-3:**

Homestead garden module and its Importance, production plan and budgeting, vegetable production technologies , seed bed preparation, raised bed and pit preparation , quality seed, organic fertilizer and Farm Yard Manure (FYM) Preparation

**Day-4:**

Problem Analysis for Homestead Production and Local Poultry, Function of chemical fertilizer for vegetable production, Integrated Pest Management (IPM), Collective Action, Intercultural Operation

**Day-5:**

Pest management and trial setup on vegetable and fruit, Practical work on Pit, raised bed and Farm Yard Manure preparation, Space Planning

**Day-6:**

Fruit tree management, Role play on collective action

**Day-7:**

Practical on Integrated Pest management, Fruit and fruit tree fertilization, Intorduction of Poultry Module , Production Plan

**Day-8:**

Information on input market, Poultry Input management, Poultry housing and Hazol preparation –Practical, Importance of Hazol for broody Hen management

**Day-9:**

Agro-ecological System Analysis (AESAs) on vegetables and fruit , FMA (Farm management Analysis) on Poultry (Practical)

**Day-10:** Trial set-up on Poultry , Chicks and pullet rearing and its management,Poultry Disease management and Vaccination service, Ballot Box preparation and Question setting on Hometead and Poultry Module, Networking, ICT for marketing and production information



**Day-11:** Disaster Risk Reduction and Blue Gold Perspective, Primary health care of poultry, Bio-Security , Disease management and disease calendar, Horizontal learning, Women empowerment through homestead and local poultry

**Day-12:** Post evaluation, Farmer Field Day demonstration, FFS register writing, ODK form use, closing

## 1.5 Training Methodologies

FFS is an experiential learning approach. To keep this principle in mind the following methodologies followed by the experts to make the session interactive and participatory.

- Group work ( crop calendar, problem analysis, farm management analysis etc.)
- Field work (Pit & raised bed, farm yard manure preparation, pest identification, space planning, hazard preparation , feed preparation , FMA and AESA etc. )
- Participatory discussion ( all sessions)
- Power point presentation (Pictures and Videos)
- Role play (Collective action)
- Demonstration: Poultry shed, broody hen management with hazard

## 1.6 Resource persons

Resource persons from livestock department and Blue Gold Programme conducted the sessions. Local Input Trader and advance poultry rearer also attended relevant sessions for networking and experience sharing.

Director & Program Coordinating Director (PCD), Focal Point Directorate of Livestock Services, Deputy Director - Department of Agricultural Extension Khulna, Zonal coordinator Blue Gold programme attended the training programme at the opening and closing events as honorable guests. Their valuable speeches encouraged the participants and motivated them to perform their duties to help improve livelihood of the polder dwellers.

Pre and Post evaluation was conducted for participants in a written test with a set questionnaire for evaluating their improvement.

During the courses different games, group quiz competition, cultural events were organized for keeping participants active, attentive and cheerful. Best performers were awarded by gifts.

During the TOT, every day a planning meeting took place in the evening. All facilitators and host team leaders attended these meetings. Host team leaders and facilitators reviewed the whole day activities to learn from the participants their views regarding the

facilitation, topics discussed, practical sessions and others. They noted down the issues and action taken according to meeting and then discussed the plan for the following day.
