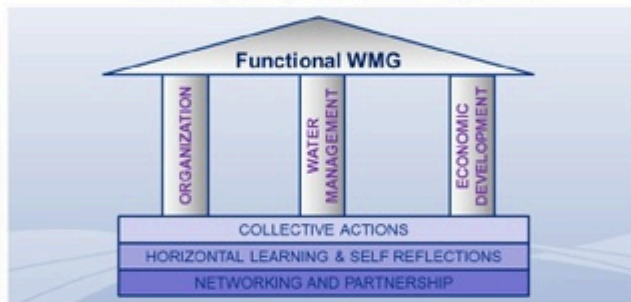

Brief Report on Refocusing WMA Capacity Building

 January 20 & January 25, 2018

Introduction

Two workshops on Refocusing WMA Capacity Building were held in Patuakhali and Satkhira offices for Patuakhali, Khulna and Satkhira areas on January 20 and 25, 2018, respectively with an aim to share and getting feedback on the newly developed capacity building approach for WMA. The hosts were, Blue Gold Program, Rural Planning, Technical Specialist MS. Hossain, Trainers/Instructors, Mrs. Khatun, Training/Instructor and Social Communication Extension in these two workshops.

At these workshops total 88 participants (i.e. public representatives, coordinator and other members of local team of BGP TA attend).

Training Expert facilitated the workshop by using group-work, explained the main objectives and intention of the refocusing capacity building of WMA. He also clarified the BGP refocusing WMA capacity building approach and process for self-reliant WMA. In his presentation he described that the key objectives of refocusing will be demand driven, cost-effective, experiential, oriented toward WMA or self-reliance orientation. He emphasized that the CFP will play key role in WMA capacity building process. He stated that what will be the required knowledge, skills and behavioral change of CFP in this process. The CFP and Public Representative considered that agree and describe the reason why this knowledge, skills and behavioral change will be required. Following are the complete resource data:
