**Background of the Training:**

Labour Contracting Society (LCS) is a group of contractual workers who participate in the water management infrastructure construction in an efficient manner. During each work time, for this type of income and resource related activities, the landless and poor females are the main participants and beneficiary. This type of income and resource related activities last for around ten to three months.

LCS work is not only about earthwork, but it can be said that there is more work that are related to the water based office. Since, they have to do some official work so their training is important.
