Introduction

The 4th batch of ToF course for Catchment Committee Facilitators on Sluice Catchment O&M planning process has successfully completed on 12 September 2018. The objective of the training course was to develop the capacity of Catchment Committee members who will facilitate to prepare Catchment O&M Planning Process at the WMG and Catchment level involving the farmers, UP and WMO representatives.



Participants

A total of 24 catchment committee members + 13 CDF + 1 O&M-CDF + 1 PC from Polder 02 participated in five days of training course. On 4th and 5th days training the experienced 02 catchment committee facilitator from Khulna attended the course. In 1st two days of training course, Mr. Bart International

Brief of the training

The training course was organized at PMU, Satkhira, Satkhira office meeting hall room, among room and participants accommodation facilities are in the same building including other related facilities. For the participants expected to the training venue at 1st day 08:00 afternoon. The training course was formally inaugurated by the Zonal Coordinator Mr. Joyal Abedin.

The following key sessions were conducted in 5 days training course:

- Roles & functions of WMG's in water management for higher agricultural production and self-sustaining organizations
- Steps and process of preparation Catchment O&M Planning Process through data collection from the WMG
- Analysis of WMG structure, community people/NGO members behavior in learning situation and identify the applicable techniques and required skills for facilitation of O&M planning process
- Steps and process of facilitating "Operation & Maintenance Catchment Plan" preparation
- Roles and functions of the O&M Sluice Catchment Committee in implementation and revision O&M plan

Field Practice & Demonstration

On 1st day just before lunch representative 02 Catchment Committee Facilitator from Polder 02, from Polder 02 and 03, the participants were taken to the field for sharing their experience of Sluice which increased the value of training and confidence of the Catchment Committee Facilitators. After the lunch, the participants were taken to the field in 02 groups for data collection from 10 WMG under 02 Catchment in different area of Polder 2.

After lunch, the participants returned to the venue and prepared their presentation at night for the next day's morning presentation. The 02 batch of Catchment Committee Facilitators are Polder 2.
